

# KOSCIUSKO COUNTY COMMUNITY FAIR PARADE REGISTRATION

## Rules & Information

- The theme for the parade is **“Red, White, & Moo” Kosciusko County Fair Invites You.**
- Parade will begin at the railroad underpass, west of Collier’s Heating & Air Conditioning.
- Announcer’s stand will be located in the Antique Area on the West Drive of the Fairgrounds.
- Parade check-in & lineup will take place on South McKinley St. and Durbin St., west of Warsaw Chemical.
- Parade judging will begin at 3:30 p.m.
- *Awards will be presented at the Announcer’s Stand.*
- Categories are 4-H, Antique Vehicle, Float, Equestrian, Commercial, Best of Theme, Club, Walking Unit. (Walking units will need to provide a motorized unit to accompany them along the route and Equestrian units will need to provide their own manure clean up along the route.)
- No rain date. Parade will be held unless a state of emergency is in effect.
- **No handing out or throwing items (candy etc) from any moving vehicle.**
- **A responsible person walking adjacent to respective entry & close to curb line may give out handouts. Any violators are subject to having entry disqualified & removed from the parade.**
- All entries need to have a **brief** written statement to be read as your unit passes the announcement stand. **(Parade will not stop to read statement)** Statements to be submitted with entry.
- Published guidelines are subject to change. All decisions by Parade Committee are final.
- Entry deadline is Noon on Friday, July 3, 2009. (Anyone entering the Parade after the deadline may participate, but will be placed at the end of the Parade.)
